Grant requests can not exceed \$1,000

Use of Grant Money: All Grants must be used to benefit the community of Folly Beach as a whole or a specific portion thereof. (The Foundation's selection committee will determine if the grant proposal is aligned with the overall goal of supporting Folly's diverse community.)

Eligibility Requirements: Must meet Part I, II, or III to be eligible

Part I. Only Folly Beach based community organizations may apply.

- If incorporated Organization must have F.B. as home address listed with SC Secretary of State's office. (To be eligible)
- If an IRS recognized non-profit Organization must have F.B. as home address. (To be eligible)
- If unincorporated A majority of members must be F.B. residents and group's bank account must be associated with a F.B. Address. (To be eligible)

Part II. Special Exceptions – (Pre-approved by Board) 1. Pet Helpers 2. Save the Light

(If your organization wishes to apply for a special exception, detail your reasons and send them to the Foundation via email for consideration by the board of directors.)

Part III. Start a New Non-Profit - Individuals wishing to start a new Folly Beach based non-profit my apply. (Request a special application form from F.B.C.F.)
